Stormwater – What’s the Big Deal?

- Rain washes pollutants away
- Flows into inlets, underground pipes, ditches
- Discharge directly to creeks or the Lake
- No treatment to remove any pollutants
- Impacts water quality, aquatic life, recreation
- **Sediment-bound phosphorus causes algal blooms in Clear Lake** – focus of significant control efforts
