On March 02, 2021, I, Barbara C. Ringen, Lake County Tax Collector, was directed to conduct a public auction sale by the Board of Supervisors of Lake County, California. The tax-defaulted properties on this notice are subject to the tax collector's power of sale and have been approved for sale by a resolution dated March 02, 2021 of the Lake County Board of Supervisors.

The sale will be conducted at [www.bid4assets.com](http://www.bid4assets.com) starting at 8:00 a.m. (PST) on Saturday, June 05, 2021 and ending on Tuesday, June 08, 2021, as a public auction to the highest bidder for not less than the minimum bid as shown on this notice. Parcel closing times vary. See website for details. Parcels receiving no bids may, at the tax collector's discretion, be reoffered at [www.bid4assets.com](http://www.bid4assets.com), within 90 days at a minimum price appropriate to stimulate competitive bidding. Due diligence research is incumbent on the bidder as all properties are sold as is. The winning bidder is legally obligated to purchase the item. Computer workstations will be available to persons who need them at the Lake County Library during business hours. The County and its employees are not liable for the failure of any electronic equipment that may prevent a person from participating in the sale.

You may also bid by fax using an offline bid form provided by Bid4Assets. Pre-registration is required. Register on-line at [www.bid4assets.com](http://www.bid4assets.com) by 1:00 p.m. (PST) Tuesday June 01, 2021. A single \$5,000.00 refundable deposit (plus \$35 processing fee) is required to bid. Deposit must be either a certified check or wire transfer and received by Bid4Assets no later than 1:00 p.m. (PST) Tuesday, June 01, 2021. The deposit will be applied to the successful bidder's purchase price. The winning bidder is legally obligated to purchase the item.

Full Payment to Bid4Assets by wire transfer or certified check is required by 2:00 p.m. (PST) on Friday June 11, 2021. Deed information indicating how title should be vested must be submitted to Bid4Assets prior to accessing the deposit instructions at [www.bid4assets.com](http://www.bid4assets.com). Transfer taxes will be added to and collected with the purchase price.
