

**Amendment No. 2 TO THE AGREEMENT BETWEEN COUNTY OF LAKE AND  
HILLTOP RECOVERY SERVICES FOR SUBSTANCE USE DISORDER OUTPATIENT  
DRUG FREE AND RESIDENTIAL SERVICES FOR FISCAL YEAR 2021-22**

This Amendment No. 2 to Agreement is made and entered into this 1<sup>st</sup> day of January 2022 by and between the County of Lake, a political subdivision of the State of California (hereinafter referred to as "County") and Hilltop Recovery Services (hereinafter referred to as "Contractor").

**RECITALS**

**WHEREAS**, the parties hereto have entered into an Agreement dated July 1, 2021, under which Contractor will provide Substance Use Disorder Outpatient and Drug Free and Residential Services Adult Residential to eligible residents of County; and

**WHEREAS**, this Agreement was amended on October 26, 2021 to reflect a rate change implemented by the Department of Healthcare Services for Fiscal Year 2021-22 which did not affect the total compensation payable under the Agreement and which also added Exhibit D – titled "Business Associate Agreement" to the Agreement; and

**WHEREAS**, the County has procured additional grant funding to support the expansion of residential treatment services provided under this contract and now desires to amend the Agreement for a second time to increase the number of bed days available for purchase which in turn increases the total compensation payable under this agreement.

**NOW, THEREFORE**, the parties hereto agree as follows:

**3. COMPENSATION.** Contractor has been selected by County to provide the services described hereunder in **Exhibit A**, titled, "**Scope of Services.**" **Compensation to Contractor shall not exceed Two Hundred Ninety-Two Thousand, Fifty Dollars (\$292,050.00).**

The County shall compensate Contractor for services rendered, in accordance with the provisions set forth in **Exhibit B**, titled "**Fiscal Provisions**" attached hereto and incorporated herein, provided that Contractor is not in default under any provisions of this Agreement.

**4. PAYMENT TERMS.**

4.2 County shall pay Contractor for a total of **FOUR (4)** (*Increased from Two (2) for July 1, 2021 to December 31, 2021*) SABG funded fee for service beds for inpatient residential services for the months of January through June 30<sup>th</sup>, 2022. Service to be provided at 14715 E. Highway 20, Clearlake Oaks, CA 95423.

A. Residential Services Bed Purchased \$170 daily  
\*to be paid in monthly installments of **\$20,683.34.**


