

**AMENDMENT No. 1 to the AGREEMENT BETWEEN COUNTY OF LAKE
AND JUNE WILSON-CLARKIN, LMFT FOR SPECIALIZED
PSYCHOTHERAPY FOR FISCAL YEAR 2021-22**

This Amendment to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as “County,” and June Wilson-Clarkin, hereinafter referred to as “Contractor,” collectively referred to as the “Parties.”

RECITALS

WHEREAS, the parties hereto have entered into an Agreement dated July 1, 2021 under which contractor will provide specialized mental health services to the residents of Lake County; and

WHEREAS, the parties desire to amend the Agreement to increase the total compensation payable under the Agreement by \$10,000.00 for a new contract maximum of **Fifteen Thousand Three Hundred Dollars (\$15,300.00)**.

NOW, THEREFORE, the parties hereto agree to the following Amendment to the Agreement:

3. COMPENSATION. Contractor has been selected by County to provide the services described hereunder in **Exhibit A**, titled, **“Scope of Services.” Compensation to Contractor shall not exceed Fifteen Thousand Three Hundred Dollars (\$15,300.00)**.

The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.
