

**Amendment No. 1 to the AGREEMENT BETWEEN COUNTY OF LAKE AND  
NATIVE AMERICAN MENTAL HEALTH SERVICES dba NORTH AMERICAN  
MENTAL HEALTH SERVICES FOR TELEPSYCHIATRY SERVICES  
FOR FISCAL YEAR 2021-22**

**This Agreement is made and entered into by and between the County of Lake, hereinafter referred to as “County.” and Native American Mental Health Services dba North American Mental Health Services (NAMHS), hereinafter referred to as “Contractor,” collectively referred to as the “parties.”**

**WHEREAS**, County and Contractor entered into an Agreement July 1, 2021 wherein Contractor will provide Specialty Mental Health Services consisting of Medication Evaluation and Medication Follow-up; and

**WHEREAS**, County must meet Federal capacity requirements as outlined by the Network Adequacy Certification Tool (NACT) to provide 1.52 Full Time Equivalent (FTE) staff for Adult Psychiatry and 0.85 Full Time Equivalent (FTE) staff for Child and Adolescent Psychiatry; and

**WHEREAS**, due to staffing changes County must now increase the FTE associated with this Agreement to meet NACT requirements; and

**WHEREAS**, this change necessitates an increase in the contract maximum of \$324,418.00.

**NOW, THEREFORE**, the parties hereto agree to the following Amendment to the Agreement:

**3. COMPENSATION.** Contractor has been selected by County to provide the services described hereunder in Exhibit A, titled, “Scope of Services”. **Compensation to Contractor shall not exceed One Million, Five Hundred Thirteen Thousand, Four Hundred Fifty-One Dollars and Forty-Four Cents (\$1,513,451.44).**

**4. PAYMENT TERMS.** County shall reimburse Contractor for services provided per the schedule below:

**4.1 TELEPSYCHIATRY FEES:**

<i>M.D.:</i>	<i>\$260/hour</i>
<i>Nurse Practitioner:</i>	<i>\$220/hour</i>
<i>Physician Assistant:</i>	<i>\$220/hour</i>
<i>Psychologist:</i>	<i>\$220/hour</i>

*(Billing for an 8 hour day plus 1 hour of charting for a total of 9 hour day)*

**This contracts allocates \$1,313,451.44 (One Million, Three Hundred Thirteen Thousand, Four Hundred Fifty-One Dollars and Forty-Four Cents) towards telepsychiatry fees to provide 1.52 FTE of psychiatry for adults and 0.85 psychiatry for children/adolescents.**
