**RESOLUTION AUTHORIZING AN AMENDMENT TO THE STANDARD AGREEMENT
BETWEEN THE COUNTY OF LAKE AND THE DEPARTMENT OF HEALTH CARE
SERVICES FOR THE PERIOD OF JULY 1, 2021 THROUGH JUNE 30, 2024 AND
AUTHORIZING THE BEHAVIORAL HEALTH DIRECTOR TO SIGN THE STANDARD
AGREEMENT AND THE CONTRACTOR CERTIFICATION CLAUSE (CCC 04/2017).**

THEREFORE, BE IT FURTHER RESOLVED that the Board of Supervisors of the County of Lake hereby authorizes the Behavioral Health Director to sign the amended Standard Agreement and the form titled “Contractor Certification Clause” on behalf of the County of Lake. A certified copy of this resolution shall be delivered to the Lake County Auditor/Controller and Lake County Behavioral Health Department.
